### COMPUTERS IN LIBRARIES 2009 EXPERIENCE

After twenty years of attending ATLA conferences, I decided to dip my feet into another pond this year. The ever increasing presence and rapid advance of technology led me to the Computers in Libraries 2009 conference held this year in Arlington, Virginia from March 30 to April 1. The Computers in Libraries conference is an annual three-day event, with preand post-conference workshops, covering various aspects of library and information delivery technology. This year's theme was "Creating Tomorrow: Spreading Ideas & Learning."

#### The Game Plan

For those of you who have never attended one of the CIL conferences, here's how it worked. Each day started off with a keynote address by an intelligent, interesting, and enthusiastic professional addressing issues of current concern, followed by a series of fortyfive minute presentations throughout the day given by other intelligent, interesting, enthusiastic professionals from all over the country and from all types of institutions. The presentations were separated by coffee & snack breaks (you're familiar with those) and vendor exhibits (you're familiar with those too). Evening sessions were provided that were informal, fun, educational, and social in nature. The conference was divided into tracks based on various themes, for example, Track A on Cultivating Innovation & Change, Track B on Open Libraries, Track C on Social Software, Track D on Services & Virtual Reference, and Track E on Next Gen Catalogs. Those were the tracks for Day Two. The tracks for each day varied. Each track was filled with five presentations, which means the conference included a whopping seventy-five presentations in addition to the three keynote addresses. All of the keynotes and presentations were recorded, which allowed for the preparation of a full-conference CD-ROM for those wanting one (for a fee, of course, but half-price to attendees). Workshops were provided on the day before the conference and the day after the conference for folks to have more in-depth training on a variety of topics.

#### PDF and MS Word Documents Available Online

Some of the presentations and PowerPoints (including those of the keynote speakers) are available to anyone accessing the Web site. On the main page, just take a look under Conference Presentations at <a href="http://www.infotoday.com/cil2009/program.asp">http://www.infotoday.com/cil2009/program.asp</a> (keep clicking under the sessions listed until you find something you're interested in), and there you will find PDF files or MS Word Documents for downloading. The downloadable items are highlighted in yellow. For example, the presentation "Library Website and Library Catalog: One Stop!" (<a href="http://conferences.infotoday.com/documents/32/E203">http://conferences.infotoday.com/documents/32/E203</a> De Groff.pdf) by Amy Begg De Groff and Danny B. Boumann is right there for you. So, do take a look around. Granted, some of the presentations are geared toward other types of libraries than the ones we find

ourselves in, but they do provide many ideas that can be adapted to our own situations with some imaginative tweaking.

### Overall Impressions

During the conference itself, my own experience involved "jumping the tracks." Rather than debrief you all on every presentation I attended, I will give you my impressions of the keynote addresses and my overall impressions of the conference based solely on my attendance of fifteen out of the seventy-five presentations.

Keynote speaker Lee Rainie (Director, Pew Internet & American Life Project) presented the results of an excellent sociological study of why and how people use social networks to share ideas, learn, and solve problems followed by recommendations on how libraries can serve the needs of people today and in the future based on their various social networking patterns and uses of technology to fulfill their informational and social needs. (http://www.infotoday.com/cil2009/day.asp?day=Monday)

Keynote speaker Paul Holdengräber (Director, Public Programs, New York Public Library) was interviewed by Erik Boekesteijn (Concept Developer and Project Manager, Science and Innovation Department, Delft Public Library Shanachie Tour). Holdengräber was brought to the NYPL with the charge to "oxygenate" the library. In this, he has succeeded, largely due to his being the founder, curator, and voice of "LIVE from the NYPL," an engaging public program of conversations, debates, and performances. With reference to the two marble lions flanking the front doors of the NYPL, Holdengräber said that his goal is "to make the lions roar." What I found most interesting were his thoughts on the fascination he has with the relationship between the public and the private. Libraries are places that connect the two. He said: "I'm interested in what happens in this place that is public, where we go and read and do an activity which is extremely private." And further, "One of the things I like to believe in is that somehow we go from this very private experience of reading to this public manifestation which you saw live to the return to a private experience." He compared a library to a home and expressed further fascination in the way we "explode that home so that we make that home a library ... without walls, a library that is porous, a library that is everywhere. A library that has the one gift I want to have: the gift of ubiquity." He said his job, as is our job, is to make the ideas we preserve desirable, even irresistible, and to display hospitality. This will foster interaction, and make people feel at home with each other and the world of ideas, thereby helping them to "continue to have a life."

Keynote speaker Michael Edson (Director of Web & New Media Strategy, Office of the CIO, Smithsonian Institution) is advocating for a Smithsonian Commons. He believes that "the Smithsonian will be relevant *only* if it returns to its roots and champions the democratization of knowledge and innovation; *only* if it uses technology to create a free and open commons; and *only* if it steps up to the plate and applies its resources and energy to this purpose with urgency and verve." Free resources, contrary to common opinion, can generate significant income whereas the restriction of access causes the loss of creativity, innovation, and the advancement of knowledge that are essential to a participatory democracy. (http://www.infotoday.com/cil2009/day.asp?day=Wednesday)

The conference presentations reflected the reality that this is the era of social networking and information sharing (although not without complications, i.e. Digital Rights Management (DRM), copyright issues, and profit-minded business practices). The importance of distributing information widely, conveniently, engagingly, and freely was a constant theme. The overarching opinion was that the standard ILS provided by a proprietary vendor is dead, and rising up out of its ashes is Software as a Service (SaaS) and Open Source applications. Some Open Source software is free and easy; other Open Source software is free and not so easy (hence requiring the need for paid commercial support). Information distribution is going over the wall and down the road, which is to say it's going mobile (i.e. to cell phones, Kindles, etc.). The drive is toward more interactive library Web sites and catalogs. As the OCLC report on *Online Catalogs* also points out, the method of information delivery is much more important and dynamic than in the past. The need for simplicity in the midst of multiplicity is desperately needed. Although the challenges are many, the benefits could be awesome with innovation, persistence, and good ethics.

#### ONLINE CATALOGS REPORT FROM OCLC

An OCLC research team headed by Karen Calhoun has produced a report entitled "Online Catalogs: What Users and Librarians Want."

(http://www.oclc.org/reports/onlinecatalogs/fullreport.pdf) This is a sixty-eight page report detailing the results and findings of a study designed to identify and compare data quality expectations of end users and librarians and making recommendations about ways the catalog can be enhanced to meet the needs of both audiences. The needed enhancements include enriching bibliographic content (e.g., with summaries, reviews, tables of contents, etc.), generous linking to resources, implementing better delivery methods, and improving relevancy ranking. Please take the time to read this document and take your thoughts to our own forum, ATLATech, to carry on a dialogue about the findings of this survey.

# RDA UPDATES

# PCC DOCUMENTS

The Task Group on BIBCO Standard Record Requirements has issued an Interim Report (<a href="http://www.loc.gov/catdir/pcc/bibco/TG">http://www.loc.gov/catdir/pcc/bibco/TG</a> InterimRpt BSR-MAP5 20Mar09.pdf). This group is charged with defining a set of required elements for bibliographic records for monographs using a single encoding level. Issued March 20, 2009, this report describes the characteristics of the BIBCO standard record, contains a MAP (Metadata Application

Profile) for printed books, a delineation of the guidelines used to make the decisions present in the profile, and the Task Group recommendations.

The Provider-Neutral E-Monograph Record Task Group Report issued its Final Report (<a href="http://www.loc.gov/catdir/pcc/bibco/PN-Final-Report.pdf">http://www.loc.gov/catdir/pcc/bibco/PN-Final-Report.pdf</a>). This document, dated March 25, 2009, presents the charge to the Task Group, the characteristics of a Provider-Neutral E-Monograph, a MAP for one, Task Group recommendations, next steps for implementation, examples, and a FAQ. A Provider-Neutral E-Monograph Record is "a single bibliographic record that covers all equivalent manifestations of an online monograph." This is in contrast to the previous model of having a separate record for each manifestation. Policy decisions made in line with the proposals in this document, if approved, will affect the coding of PCC master records in OCLC and will require local libraries to make choices about how to represent these manifestations in their local databases.
